Rear Garden:

T1: Large Sycamore: Reduce crown back to previous most recent reduction points whilst retaining a suitable amount of furnishing growth to ensure crown continuity. Ensure a 1.50-2.00m clearance of buildings. No crown thinning. Reason: To control encroachment. The tree is growing within close proximity to the building.

T2, T3 & T4: Group of Mature Sycamore: Thin crown density of the three trees by 20-25%. Reason: General maintenance.

T5: Purple Plum: Thin crown density by 20%. Reduce extraneous branches back in to main crown structure. Remove dead wood. Reason: General maintenance.

T6: Wych Elm: Fell to point just above main fork. Reason: This tree is now totally dead.

T7: Large Poplar: Repollard. Reason: General maintenance.

T8: Mature Lime: Thin crown density by approximately 30%, selecting strong viable growth in order to promote a more natural crown structure. Reason: General maintenance.
