Proposal:

FRONT GARDEN: 1 x Evergreen Holm Oak (*Quercus ilex*) (T1) - 2 x large stems from same bole -treat as single crown and reduce by 25%, (1.75m) to suitable growth points, thin crown by 10% and remove any crossing branches.

REAR GARDEN: 1 x Sycamore (*Acer pseudoplatanus*) (T2) - Pollard by reducing all stems by 50%, (4m) to suitable unions

The Council has considered your application dated 12 October 2020 and decided to grant consent subject to the following condition(s):

Conditions and Reasons:

- 1 This decision is valid for 2 years from the date of this decision or until the work is completed, whichever is the sooner.

Reason: To allow the Local planning authority to monitor the completion and standards of the work.

- 2 All work shall be carried out in accordance with the relevant recommendations of British Standard 3998: 2010. (Recommendation for Tree Work)

Reason: To ensure the preservation of the amenity value and health of the tree(s).

- 1 Please note that any approval given by the Council does not give an exemption from the requirements to comply with the Wildlife and Countryside Act 1981 (as amended), or any other Acts offering protection to wildlife.
