Proposed Work:

REAR GARDEN: 1 x Holly (T1) - Reduce extraneous branches back into main crown structure by no more than 20%.

1 x Elder (T2) - Thin crown density by 20%. Reduce crown by approx. 20%.

1 x Small Elder (S3) - Reduce by approx. 0.50m.

1 x Silver Birch (T3) - Thin crown density by 20%.

1 x Large Holly (T5) - Reduce low overhanging branches by approx. 2m.

1 x Laurel (T6) - Reduce crown by approx. 20%.

1 x Mature Elder (T7) - Reduce crown by 25-30%. Thin crown density throughout by 20

FRONT GARDEN: 1 x Olive (T8) - Reduce crown by 15-20%.

The Council has considered your notification of intended works to trees dated 01 October 2020 and does not wish to object.

- 1 This notice is valid for 2 years from the date of this letter or until the work is completed, whichever is the sooner.
- 2 You are advised that the appropriate standards for tree work are set out in BS

3998: 2010. Failure to ensure that the proposed works are carried out to these standards may result in damage to the tree(s) and may result in legal action by the Council.

- 3 Please note that any approval given by the Council does not give an exemption from the requirements to comply with the Wildlife and Countryside Act 1981 (as amended), or any other Acts offering protection to wildlife. Of particular note is the protection offered to bats, birds and their nests from construction works.
