Eucalyptus tree in the North West corner of 13 Wadham Gardens: This tree has an irregular shape with large lateral growth protruding into my client's garden at 137a King Henry's Road. Proposed work: Reduce any lateral growth into my client's garden by up to 2.5 metres. Due to current the shape of the tree, this reduction specification will not unbalance the crown or reduce the amenity value of the tree. All cuts will be made to suitable growth points in line with BS3998.
