e.g. Oak (T3) - fell because of excessive shading and low amenity value. Replant with one standard ash in same position.

Rear Garden:

- T1: Dead Cherry (close to left hand boundary): Fell to ground level.

  T2: Cotoneaster (overhanging from No.3 Harley Road): Remove any overhanging branches back to as near to the boundary as is practicable.

  T3: Yew (growing over the boundary from No.3 Harley Road) Reduce overhanging branches by approximately 1.50-2.00m whilst preserving viable growth
- T3. Tew Growing over the buildary from No.3 Harley Road) \* Reduce overhanging braining braining braining 1.30-2.00ff whilst preserving viable growing to ensure crown continuity.

  T4: Large Horse Chestnut approximately 21.00m. Remove dead Ivy stems as is practicable. Remove any Ivy regrowth on main stem. Reduce crown approximately 20-30% (2.00-3.50m) back to previous reduction points. Thin crown density throughout by 20%. Remove dead wood. Reasons: General maintenance and to control encroachment.
