IN BORDER BY HOLLY LODGE GARDENS: 1 x Holly (T1) - Reduce down by 3 metres and shape.

IN UPPER GARDEN CLOSE TO SIDE OF 99 HILLWAY: 1 x Lime (T2) - Remove lowest limb overhanging conservatory.

ON VERGE O/S 16 LANGBOURNE AVENUE: 1 x Indian Bean Tree (T3) - Reduce crown overhang on south side by up to 4m and balance/shape remainder as required. Crown clean.

ON VERGE TO FLANK OF 33 HILLWAY IN LANGBOURNE AVENUE: 1 x Silver Birch (T4) - Fell to ground level.

ON VERGE TO FLANK OF 31 HILLWAY IN LANGBOURNE AVENUE: 1 x Whitebeam (T5) - Fell to ground level.

IN SHRUBBERY NEXT TO GATE ONTO SWAINS LANE IN MAKEPEACE MANSIONS: 1 x Lime (T6) - Fell to ground level.

ON VERGE TO FLANK OF 63 HILLWAY IN MAKEPEACE AVENUE: 1 x Lime (T7) - Reduce back to most recent points of reduction (3m).

ON VERGE O/S 16 MAKEPEACE AVENUE: 1 x Pauls Scarlet Hawthorn (T8) - Fell to ground level.

ON VERGE O/S 4 OAKESHOTT AVENUE: 1 x Pauls Scarlet Hawthorn (T9) - Reduce crown overall by up to 2m.

The Council has considered your notification of intended works to trees dated 28 October 2020 and does not wish to object.
