e.g. Oak (T3) - fell because of excessive shading and low amenity value. Replant with one standard ash in same position.

T7 is a large mature twin stem ash (*Fraxinus excelsior*), the smaller of the stems leans towards the carriageway whilst the larger of the two is relatively upright. There are multiple cavities with decay on the large of the stems. The height of the tree is in excess of 18m and there is a busy junction and car parking directly beneath the crown. We have recommended the tree is reduced to an overall height of 12 metres, and the lateral extent is reduced by at least 2.5 metres to rebalance crown.
