
GREATER LONDON HOUSE 4th Floor Proposed South Facing Terrace (Existing flat roof)

P/04 Proposed Elevation and Section P/05 Existing and Proposed Elevations We have been advised, by Camden Planning Department (27/11/20), that these proposed works require Planning Approval.

The proposal is to adapt an existing, window opening at 4th floor level to form door access to an existing flat roof area bounded by an existing parapet wall.

The proposal to lower the existing window sill level to door threshold level will only be visible from above 4th floor level. There are no other buildings of that height nearby.

Greater London House has a reinforced concrete frame construction with rendered masonry infill panels. The proposal is to remove a small area of the masonry panel below an existing window. The existing flat roof is below 4th floor level. The terrace will have a new boarded floor on joists to meet 4th floor level. The existing parapet wall is 1450mm above 4th Floor level. Illumination to be provided by downlight bollards below parapet height.


Rainwater will drain between the boards onto the existing flat roof and then to the existing rainwater drainage system. The existing window to be replaced with doors of similar pattern.




Existing parapet wall (looking south) 1450mm above 4th floor level

HISTORY:

Greater London House Originally, Carreras Factory 1926-8 Architect M.E. and O.H. Collins, with A.G. Porri

Large art deco former tobacco factory building in Mornington Crescent, now called Greater London House.

The plans for the main structure were by A.G.Porri, with Egyptian influenced façade designed by M.E. and O.H. Collins

DESIGN PROPOSAL:

The context of the 4th Floor elevation, behind an existing parapet wall, atop the Egyptian art deco, south facing façade, although not visible from ground level, it is surprising a door at this location was not included in the original design.

The proposal will make use of existing features to provide access to an external area to the benefit of user welfare.

Floor area is the existing flat roof, approx. 20m2. Door width and head height the same as the existing window.

The proposed double doors would be metal framed, thermally broken, double glazed doors to match existing window materials and colour. Height and width, as existing window opening, no new lintel required.

The access provided to the south facing terrace would be intended for use in office hours.
