Rear garden:

T1 - Horse Chestnut - Remove epicormic growth from Stem. Raise the house side upper crown lowest branches by approx 2m. This is to get greater light into the veggie patch below.

Pyranatha – (Fire thorn) Reduce height by approx 2m to balance

Front Garden:

T2 - Tree of Heaven - Crown reduce to previous reduction points by approx 2m.

This work is relatively low impact work to maintain the trees at their previous reduction points and bring more light into the beds below.
