Bay - pollard to 3 metres from ground (this tree has never been pruned and has grown wildly; as a very hardy species, we believe it will recover well even if pollarded hard. It is also encroaching on my neighbours magnolia tree, which I'd like to stop.)

Sycamore 2 - crown reduction by 30%

Sycamore 1 - crown thinning by 20-30%, crown reduction by 1 metre.
