-Shave off excess Ivy if the Ivy removal at ground level uncovers a major defect, inspector is to be called back in to carry out.

T2 - Extra Large –

-Remove major (over25mm diameter) deadwood from crown.

-Sever Ivy 2metres of clear stem up from ground level.

-Shave off excess Ivy if the Ivy removal at ground level uncovers a major defect, inspector is to be called back in to carry out.

-Selectively reduce lower lateral branches (where appropriate approximately 2metres) to balance the overall crown.

-Carry out aerial inspection.
