T2 Horse Chestnut - To crown lift branches up to the main crown break (approx 3 meters), removing branches no larger than 3cms in diameter.
T3 - Acacia To reduce back to the main stem 1 limb from neighbouring tree.
T4 Yew - Crown reduce back to previous points removing approximately 2-3 meters from the branch tips.
