T47 (Cherry) - Fell. Tree is dying due to woodworm and rot. With tree within falling distance of public path, and listed graves, please consider under 5 day notice.
T48 (Cherry) -Fell. Tree is dying and has rot 1 metre up the main trunk. with falling distance of public path, and listed graves, please consider under 5 day notice.
