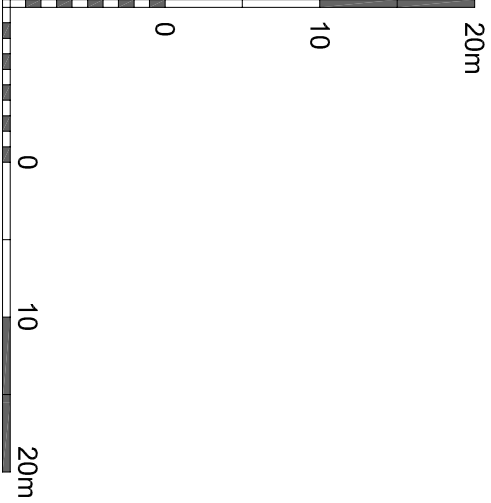

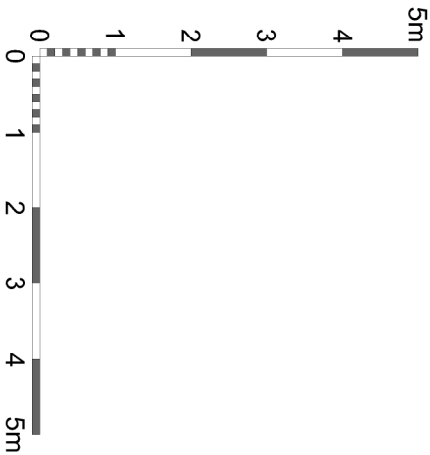


Roof

Second Floor

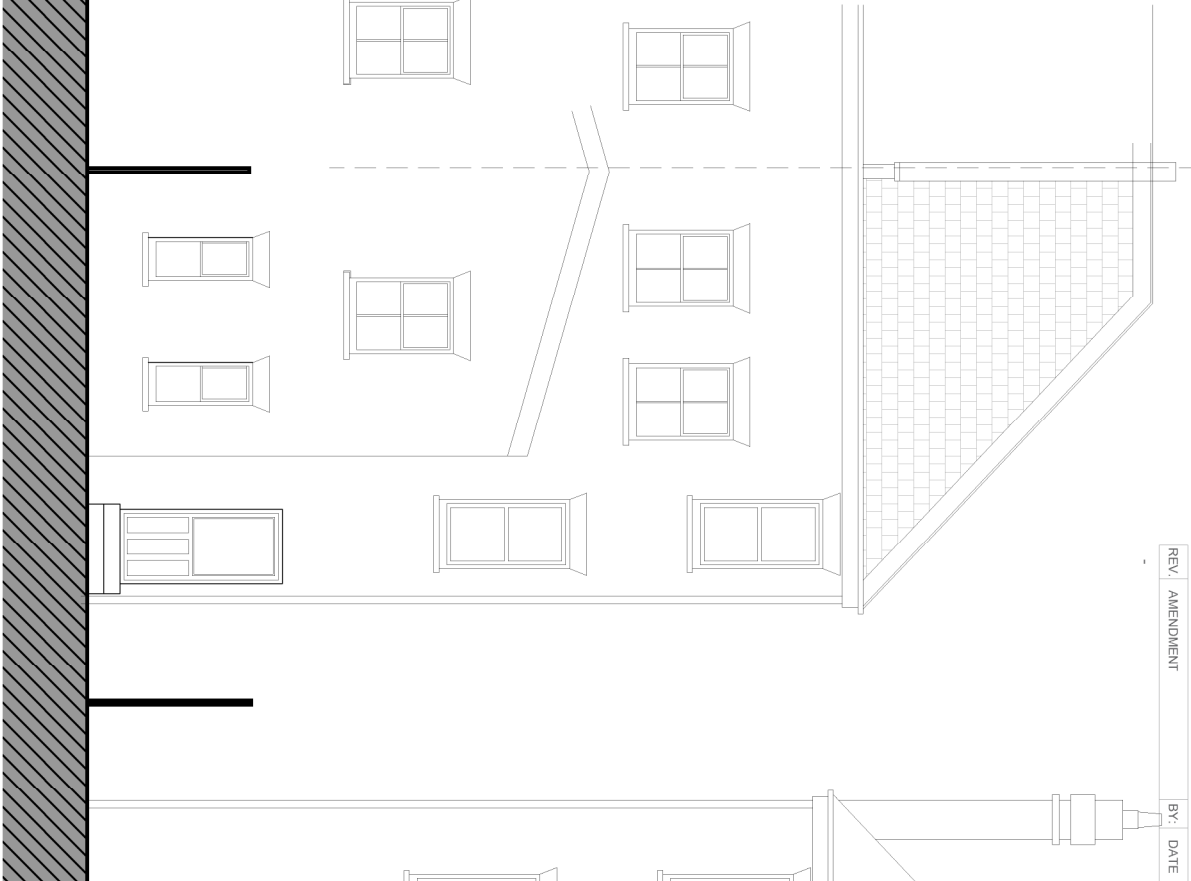
First Floor

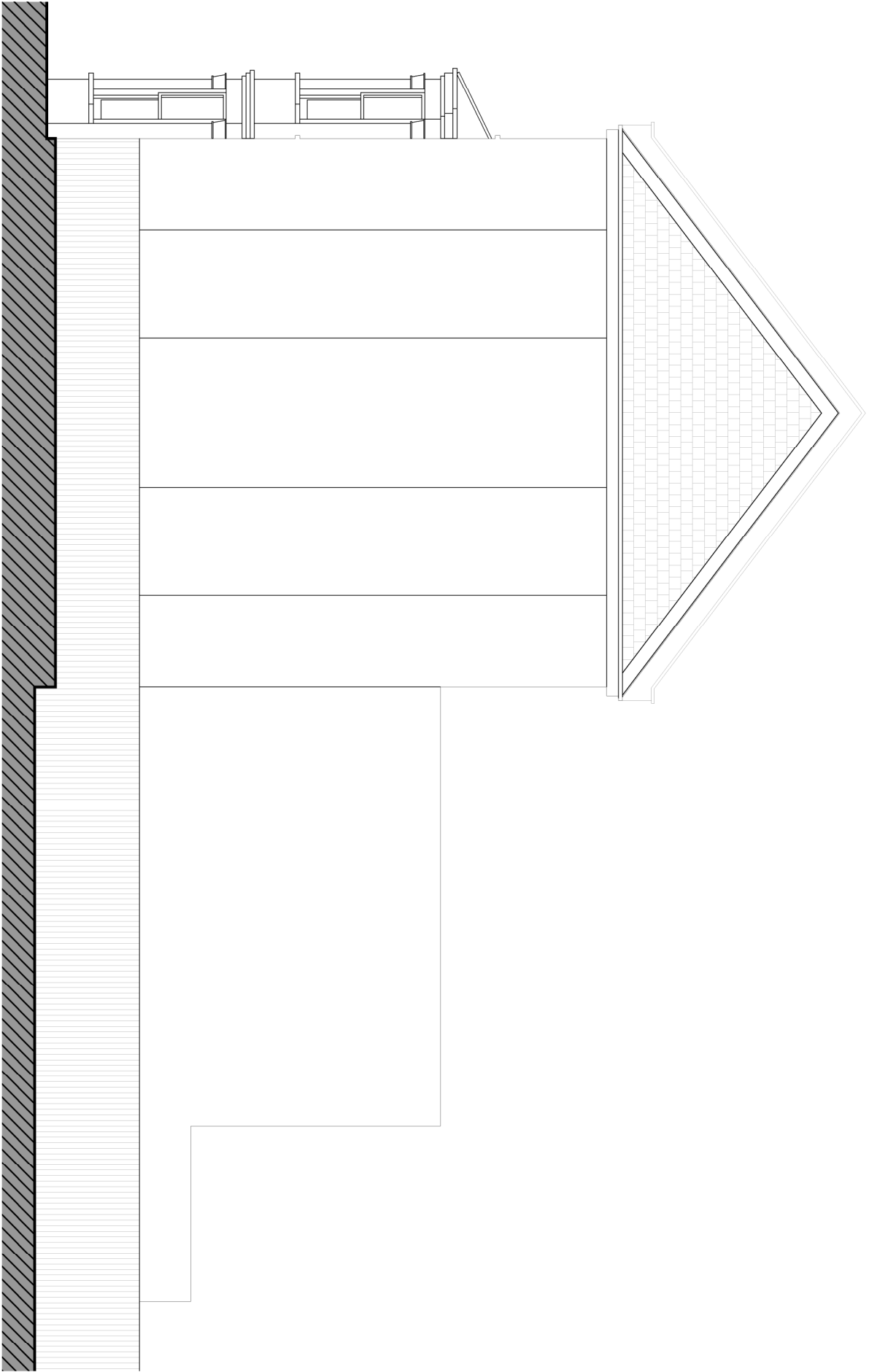
