Informative(s):

1 Reason for granting listed building consent: 84 Albert Street forms part of an irregular terrace of 20 Grade II listed stock brick houses, dating from 1844-5 and situated in the Camden Town Conservation Area.

The property was converted to flats and the application seeks to reconfigure some of the modern works which date from this time. The proposals would not impact on the legibility of the historic floorplan, nor would they impact on historic fabric. Externally, the proposal seeks to replace the modern French doors sitting behind the existing parapet with timber replacements, as advised at pre-application stage. The submitted detailing for the doors is acceptable. The proposed works will not harm the special interest of the grade-II-listed building.

The application has been advertised in the press and by means of a site notice, whereby there were no consultation responses. The site's planning history has been taken into account in making this decision.

Special attention has been paid to the desirability of preserving the special interest of the listed building, under s.16 of the Listed Buildings and Conservation Areas Act 1990 as amended by the Enterprise and Regulatory Reform Act (ERR) 2013

As such, the proposal is in general accordance with policy D2 of the Camden Local Plan 2017. The proposed development also accords with the London Plan 2016 and the NPPF.
