We have a large tree in our front Garden. The species has been identified as a Paulownia. We pruned it (with permission) in 2018 but it grows very fast and we need to prune it again as the canopy blocks light to both our house and our neighbours houses (at #1 and #5), and hangs into the public footpath. We wish to instruct a tree surgeon to perform a 35% crown reduction.
