- reduce lateral branch length to match, shape, balance and tidy
- remove any dead/damaged branches

T2-Silver Birch(Betula pendula)

- reduce crown by 24% to suitable growth points using rigging equipment to safely lower branch sections to ground in a controlled manner
- reduce lateral branch length to match, shape, balance and tidy
- remove any dead/damaged branches

T3-Apple(Malus)-dead

- section fell to ground level
- grind out stump to 350mm below ground level

All works for routine maintenance the Apple To fell is Dead.
