In accordance with the requirements of paragraphs 2 and 3 of Schedule 17 to the High-Speed Rail (London – West Midlands) Act 2017, the nominated undertaker hereby requests approval of PLANS AND SPECIFICATIONS relating to the following development authorised by the Act.

1. Nominated undertaker's submission reference number: LBC.S112.PS.20

2. Description of the proposed development:

Park Village East Wall Berm and Uppstand Support Structure– A six metre by three metre supporting berm and upstand to structurally support the existing Park Village East (PVE) retaining wall. The berm will be located in the railway cutting, adjacent to the existing PVE retaining wall and extending from Euston Scissor Box (open section) to Parkway Tunnel.

Euston Scissor Box (open section) – An open box that will structurally support the portal and provide an air gap between the Euston Tunnels and Scissor Cut, located within the railway cutting bound by Mornington Street and Granby Terrace Bridge and forming part of the portal for the new HS2 tunnels.

3. Location at which the development is to be undertaken:

Park Village East Wall Berm and Uppstand Support Structure - Located within the Euston railway cutting and runs along western side of the West Coast Mainline tracks cutting between the Parkway Tunnel in the north and Granby Terrace in the south in the London Borough of Camden.

Euston Scissor Box (open section) – Located within the Euston railway cutting and situated directly south of Mornington Street Bridge and to the east of Park Village East in the London Borough of Camden.
