HEAR MORE ABOUT A PLANNING PROPOSAL IN YOUR AREA

Dear resident

Since approval for the recladding of the Chalcots Estate tower blocks in 2018, Camden Council has undertaken further work on the proposed design and building materials and is submitting a new planning proposal for approval.

Who we are

Quod are Camden Council's independent planning consultants for the major works project, providing planning advice on a number of key topics, including:

- Design;
- Impact on neighbour amenity;
- Impact on the character of the area, including the surrounding **Conservation Areas** and protected views;
- Sustainability and sustainable construction.

Major works background

Planning permission to replace the cladding on the five tower blocks at Chalcots Estate with a solid aluminium panel façade – as well replacing the windows and associated external works – was approved by Camden Council's Planning Committee on 24 April 2018. Following further design work, fire testing and feedback from residents, the proposal has progressed and Camden Council is preparing to submit a new application for planning permission.

The proposal

The new proposal is largely the same as the application approved in 2018. The main changes are:

- Anodised finish to the cladding panels to achieve an A1 fire safety rating.
- Additional cladding of the staircase at Blashford to provide fire separation (preventing fire from spreading) and to improve appearance.
- Revised window layout for main lounge and bedroom windows, including lowered windowsills and the removal of transom beams (where possible) to improve safety and ventilation for residents, and to improve appearance.

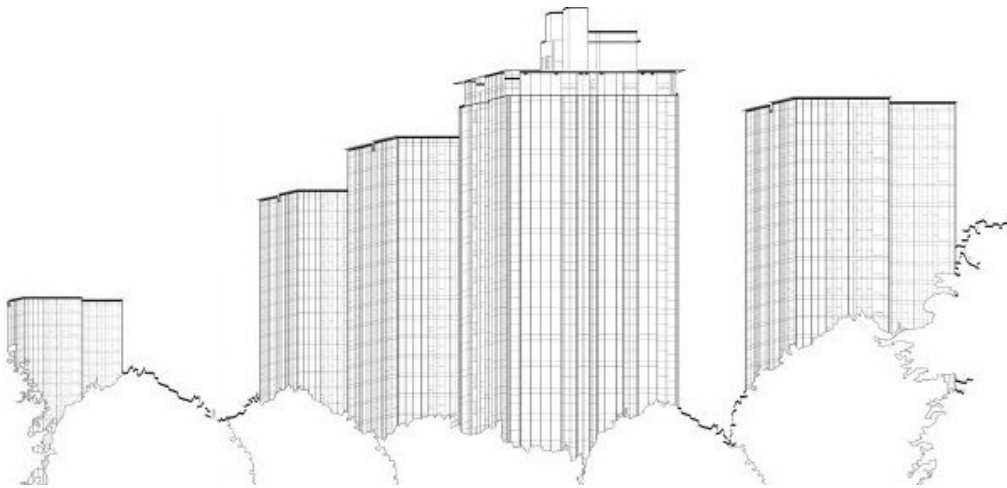

- Installation of a maintenance rail system to the roof of each block to provide safe access for maintenance, repairs and window cleaning.

What it means for you

As with the application approved in 2018, Camden Council is committed to reducing disruption for both residents of the Chalcots Estate and the surrounding roads. Camden Council will work with the local planning authority to develop a Construction Management Plan (CMP) to minimise disruption as much as possible during construction, while also complying with safe COVID-19 working practices.
