T8-Bay tree- Shape with hedge trimmers by up to 30cm.

T9-Fig tree- Reduce height by approximately 1.5 metres.

T10-Apple on left- Reduce upright trunks to a height of approximately three metres, cut back from lawn.

T5 Buddlia and in front left corner- Reduce to fence height and remove dead branches.

T6- Philadelphus- in front left corner- Reduce to fence height and remove dead branches.

T1 and T2-Two Prunus trees - Prune back from pergola by up to one and a half metres.

T7-Elder at front-Reduce by approximately 3 m.
