QTS Group are carrying out a vegetation Project on behalf of Network rail in-between Gospel Oak and Hampstead Heath Station.

The purpose of the works are to improve the rail head adhesion, signal sighting, safe walkway for railway maintenance operatives and reduce the impact that the lineside vegetation has upon the safe running of the railway and Overhead Line equipment.

We will be working to the following specification.

- All woody vegetation to be remove up to 10m from the outside running rail
- Any problematic tree species (Sycamore , Ash, Lime, Chestnut, Poplar) to be removed to the Network Rail boundary (red on the site plan)
- Any 3rd party trees overhanging the Network Rail boundary to be suitably pruned back to 10m from the running rail, any trees will left balanced (green on the site plan)
