1 The site is a 19th-century grade-II-listed townhouse.

The applicant wishes to discharge conditions 4a 4b 4c and 4d of application

2020/2685/L.

To this end he has provided: drawings showing services that use existing routes and risers; appropriately designed cornices in the ground- and first-floor rooms; appropriately designed doors, architraves and mouldings; and appropriately designed windows for the modern mews building to the rear.

The conditions are therefore discharged.

Special attention has been paid to the desirability of preserving the special interest of the listed building, under s.16 of the Listed Buildings and Conservation Areas Act 1990 as amended by the Enterprise and Regulatory Reform Act (ERR) 2013
