T1 - Plane tree on rear boundary, approximate height of tree 23 metres, approximate spread 17 metres, the top of this tree has previously been pruned but the lateral branches haven't been pruned, we would like to remove 2 metres from height and 2 to 2.5 metres lateral spread. The tree is quite large and effecting several neighbours who are complaining regarding excessive shading issues in their gardens. The tree will be pruned 1 metre below previous pruning points.

T2 - Ash Tree left hand boundary, approximate height 18 metres, approximate spread 10 metres, we wish to remove 1.5 metres to 2 metres in height and 1.5 to 2 metres in spread. This tree will be pruned to most recent pruning points.
