T1. Yew (*Taxus baccata*)

Front garden overhanging driveway.

Mature tree blocking light and outgrowing planting location, to improve light and contain spread reduce canopy by approx. 30%. (1-2m in height and 1-2m in lateral spread) Shape and balance.

T2. Magnolia

Front garden LH boundary

Semi mature tree smothered in wisteria and formally suppressed by surrounding vegetation. Low amenity value tree. Fell to ground level

T4. Apple (*Malus domestica*) Rear garden LH boundary

Mature tree growing close to rear elevation of 30 and 31 Heath Drive. To maintain cyclical pruning schedule and improve light. Reduce canopy back to previous points of reduction (1-2m in height and 1-2m in lateral spread)
