Details of the pre-application advice received				
Copy of the email from Laura Hazelton: "Yes, the sections and plan would be sufficient to show the earth works and levels. In addition, condition 6 would require these details along with details of the proposed landscaping. At the moment there is no detail of suggested materials other than grass. Would the other areas be paving, and if so what material, would it be permeable? You mention the trees would be re-planted, but they are not shown on the drawings. We don't necessarily expect them to be retained as permission is granted for their removal, but a suitable replacement should be planted, and we will need details of the species, and where they will be planted.				
Condition 7 doesn't require details to be submitted – it just requires the landscaping to be installed in accordance with the details approved for condition 6, and if the replacement trees die, they should be replaced.				
Condition 8 requires details of tree protection measures. This needs to be prepared by an Arboriculturalist, and needs to demonstrate how trees will be protected during construction and excavation, and if you do discover roots from the neighbouring tree, how you will deal with these."
