-reduce sides to match, shape to balance and tidy  
T3-Lime(Tilia cordata)-tight target w/glass greenhouse+pagoda -reduce height by 25%(3m)  
-reduce sides to match  
T4-Lawson's Cypress(Cupressus x lawsoniana)  
-section fell to ground level-some signs of early phytopthera disease and out grown space  
T5-Holm Oak(Quercus ilex)  
-reduce to previous cuts(1.5m)  
-lift canopy by 2m, shape to balance and tidy  
All work for continuous regular maintenance on a 4-5 year cycle
