T1-Front area

Magnolia(M.soulangea)

- reduce crown by 25%(1.5m from tips) to suitable growth points
- thin by 15% to allow more light through canopy
- lift on pavement side by 0.5m to give greater clearance

T2-Hawthorn(Cratageous monogyna)

- reduce crown by 25% to suitable growth points
- trim back branches overhanging pavement and inner side closest to house

T3-Small Cherry(Prunus)

- section fell to ground level

T4-Small Standard Holly(Ilex)

- fell to ground level
- dig out stump/roots

All works are for routine maintenance
