e.g. Oak (T3) - fell because of excessive shading and low amenity value. Replant with one standard ash in same position.

Rear Garden of property

Ash T1 (18M high, 1000mm dia.) - Reduce the crown of the tree back to the most recent points of reduction(4 metres). Main limb nearest house has *Innonotus hispidus* bracket at 13 metres above ground level - assess condition when climbing and further reduce for safety reasons if required.

Strawberry Tree T2 (8M high, 250mm dia.) - Reduce south side of the crown by up to 1 metre and re-shape/balance remainder of the crown accordingly. Thin crown throughout by up to 20%.

Poplar T3 (18M high, 850mm dia.) - Remove regrowth from top of broken out stem (8 metres). Reduce same stem by further 5 metres to retain pollard stem at 5/6 metres high.
