Wildstone Planning have been instructed by Brill Place Limited to submit an application to discharge Condition 9 (Detailed drawings/samples – Plot 7) for the above-mentioned planning permission granted 1st July 2020.

Condition 9 – Detailed drawings/samples – Plot 7

"Detailed drawings, or samples of materials as appropriate, in respect of the following, shall be submitted to and approved in writing by the Council before the relevant part of the work is begun:

- a) Plan, elevation and section drawings, including jambs, head and cill, of all external windows and doors at a scale of 1;10.
- b) Samples and manufacturer's details at a scale of 1:10, of all facing materials including windows and door frames, glazing and brickwork with a full scale of sample panel of brickwork, spandrel panel and glazing elements of no less than 1m by 1m including junction window opening demonstrating of the proposed colour, texture, face-bond and pointing.

A sample panel of all facing materials should be erected on-site and approved by the Council before the relevant parts of the work are commenced and the development shall be carried out in accordance with the approval given.

The relevant part of the works shall then be carried in accordance with the approved details.



Reason: To safeguard the appearance of the premises and the character of the immediate area in accordance with the requirements of policies D1 and D2 of the Camden Local Plan 2017.
