T415Ash - Remove major deadwood. Review at next inspection
T417Bay - Reduce height by approximately 2.5m and prune branches competing with T416
T429Sycamore - Remove deadwood. Remove basal growth
T454Lawson Cypress - Reduce height by 3m to check growth
T470Ash - Reduce limb growing to south west over adjacent garden by 50%
T492Horse Chestnut - Prune minor side branches to provide 4m clearance over tennis court.
T493Oak - Remove deadwood
G502Sycamore, Ash - Crown lift to provide 4m ground clearance over tennis court. Prune back lateral branches from sycamore to provide 2m clearance to tennis court fence
T517Poplar - Reduce height to previous reduction points and minor reduction to crown spread to balance
G521Sycamore x 8, Ash x 1 - Reduce height of tree closest to No4a by 2.5m and crown spread to south and east by approximately 2m. Leaving 2m clearance to building
T521aSycamore - Remove. Risk of failure
T529Lime - Reduce crown spread to provide 3m crown clearance to building
T559Holly - Reduce height by approximately 4m. Remove any dead branches
T560Lawson Cypress - Remove cable ties that are beginning to cut into bark
