e.g. Oak (T3) - fell because of excessive shading and low amenity value. Replant with one standard ash in same position.

Oak (T1) – Fell tree. There is extensive decay of the base of the tree, including root plate. Meripilus giganteus fruiting body has been present on the root plate for the past 5 years. At the base a probe can be extended up to 50cm towards the centre of the tree on the west and south sides. The tree currently leans at 5 degrees off vertical, towards the neighbours garden, over a children's playhouse that is used daily. Replant with one standard tulip tree.
