T2: Olive: Approximately 5.00m. Reduce crown by approximately 20% to shape and balance.

G1: Group of 2 x Pollarded Limes: Located on the rear boundary. Approximately 5.00-6.00m. Re-pollard back to previous, most recent reduction points.

Reasons: General maintenance.
