T3 - Tilia - reduce by 30% foliage, approximately 2 - 3m from branch ends, not beyond most recent reduction points

Woodland area - trees over hang busy main road

T4 - Tilia - reduce by 30% foliage, approximately 2 - 3m from branch ends, not beyond most recent reduction points

T5 - Tilia - crown clean, remove snapped branches and dead wood

T6 - Acer pseudoplatanus - Remove ivy, dead wood, Ariel inspection

T7 - Acer pseudoplatanus - crown clean, reduce over extended limbs over road (2m from branch ends)

Rear garden

T10 - Acer pseudoplatanus - Restorative prune - thin out reduction points 25% (1-2m) by removing thicker growth to give more natural structure whilst achieving less wind loading. (Planning needed)
