The Council has considered your application and decided to grant permission subject to the following condition(s):

The development hereby permitted must be begun not later than the end of three years from the date of this permission.

Reason: In order to comply with the provisions of Section 91 of the Town and Country Planning Act 1990 (as amended).

All new external work shall be carried out in materials that resemble, as closely as possible, in colour and texture those of the existing building, unless otherwise specified in the approved application.

Reason: To safeguard the appearance of the premises and the character of the immediate area in accordance with the requirements of policies D1 and D2 of the London Borough of Camden Local Plan 2017.

The development hereby permitted shall be carried out in accordance with the following approved plans:- E R-R00-PR-101; ER-R00-EX-101; 102; 103; 104; ER-R00-PR-101; 102; 103; 104

Reason: For the avoidance of doubt and in the interest of proper planning.

- 2 Reasons for granting permission.

The proposed side extension will infill an existing rear enclosed courtyard and will be the same height and width as the existing rear extension.

The proposed extension would sit within the envelope of the existing single storey rear extension and would be acceptable in terms of its siting, scale and design, being similar in appearance to the existing rear extension. The infill extension is subordinate in size to the host building and, due to its enclosed nature, would not be visible from the rear gardens or wider public realm and thus would not result in harm to the character and appearance of the host building or this part of the Mansfield Conservation Area.

The proposal is considered to preserve the character and appearance of the conservation area. Special attention has been paid to the desirability of preserving or enhancing the character or appearance of the Conservation Area, under s.72 of the Planning (Listed Buildings and Conservation Areas) Act 1990 as amended by the Enterprise and Regulatory Reform Act 2013.

Given the siting, scale and design of the proposed addition, coupled with the existing boundary treatment, the proposal is considered not to result in harm to surrounding residential amenities, in terms of loss of privacy, outlook, sunlight and daylight.

No comments were received following public consultation on the scheme. The planning history of the site and surrounding area has been considered when determining this application.

As such, the proposed development is in general accordance with policies A1, D1 and D2 of the London Borough of Camden Local Plan 2017. The proposed development also accords with the National Planning Policy Framework 2019.

Noise from demolition and construction works is subject to control under the Control of Pollution Act 1974.
