The structure proposed for demolition is a modern garage at the end of the garden. The building was built in the 1980s and was erected to replace the pre-existing garage/coachhouse.

Why is it necessary to demolish or extend (as applicable) all or part of the building(s) and or structure(s)?

The building is a lightweight timber structure built up against a modern (1980's) brick wall. The timber is beginning to rot where it meets the existing garden wall and the asphalt roof is also reaching the end of its expected lifespan. Minor Repairs carried out over the last few decades are in need of re-doing. The applicant wishes to replace it with a building which is built to last longer and in greater sympathy with the Georgian terrace to the south west.
