Replacement of door and window on front elevation with new window to residential dwelling (Class C3).

1 The development hereby permitted must be begun not later than the end of three years from the date of this permission.

Reason: In order to comply with the provisions of Section 91 of the Town and Country Planning Act 1990 (as amended).

2 All new external work shall be carried out in materials that resemble, as closely as possible, in colour and texture those of the existing building, unless

otherwise specified in the approved application.

Reason: To safeguard the appearance of the premises and the character of the immediate area in accordance with the requirements of policy D1 of the London Borough of Camden Local Plan 2017 and policy 2 of the Fortune Green and West Hampstead Neighbourhood Plan 2015.

The development hereby permitted shall be carried out in accordance with the following approved plans: (1106-)AP01, AP02 rev B, AP03 rev A, AP04, AP05.

For the avoidance of doubt and in the interest of proper planning.

Informative(s):

1 Reasons for granting planning permission:

The new, enlarged window would closely match a similar tall window on the floor above in terms of its design, material, proportions, vertical alignment, opening method and detailing. As such, it is considered to be a sympathetic and appropriate alteration which would improve the overall appearance at the front of the building, as well as, enhance the wider Fortune Green and West Hampstead Neighbourhood Area in which the property is situated.

There are no amenity concerns as a result of these proposals given that the new window would occupy a similar position to an existing street-facing door and window which it would replace.

The site's planning and appeals history has been taken into account when coming to this decision. No objections have been received following statutory consultation.

As such, the proposal is in general accordance with policies A1 and D1 of the Camden Local Plan 2017, policy 2 of the Fortune Green and West Hampstead Neighbourhood Plan 2015, the Publication London Plan 2020 and the National Planning Policy Framework 2019.
