The rational for approving the original application ("The units are necessary in this instance for security and maintenance purposes") remains the same. Permission was originally sought for a multi - year period (later reduced to 1 year) and it is envisaged that that the units should remain in situ until long term works to permanently secure the space can be commenced. The site has a history of being occupied by squatters and has had multiple unauthorized entries over the course of the last year. Crucially, having guardians onsite has prevented re-occupation of Rochester Square and it becoming a venue for crime or anti social behavior.
