- Reduce crown height by approximately 3-4 metres to enhance natural form.
 Trim sides all round to make a more compact rounded shape

Prune T2 Elderberry located at the Middle of rear garden according to the following specifications:

- Pollard to remove all sprouts from cut ends of branches to maintain size and appearance.
- Prune T4 Elderberry located at the left side of property rear garden according to the following specifications:

 Clean to remove all dead, diseased and broken branches 2 centimetres in diameter and larger throughout crown to improve health and appearance and reduce risk of branch failure.

Prune T5 Elderberry located at the right side of property rear garden according to the following specifications:

- Reduce back to a 2m tall stem to provide clearance to tree at rear of garden
 Prune T6 Varigated tree located at the Centre of rear garden according to the following specifications:
- Remove dead ivy stem from with in the tree
