T3 – Pear Tree; H:13m, Diameter: 40cm – Reduce tree crown by 30% and reshape- cut new vertically growing branches from top of the tree crown, remove crossing and dead branches

T4 - Lime tree; H:13m, Diameter 30cm – Reduce tree crown by 30%

T5 – Lime tree; H:13m, Diameter 30cm – Reduce tree crown by 30%

T6 - Lime tree; H:11m, Diameter 40cm – Reduce tree crown by 30%
