Holly Tree reduction in size as roots have broken into gutter drains and reached property foundations. Originally was a Holly Bush, but has grown significantly to around 8m so would like reduce height by around 50% to 4-5m. Significant size is partly due to trunk having split into 2 at base, so intend to remove one trunk.
