e.g. Oak (T3) - fell because of excessive shading and low amenity value. Replant with one standard ash in same position.

Fell one conifer, which is roof height (see photograph) It causes significant shading, restricting sunlight/daylight. It stands only 8 meters from our external wall and is subject to significant bowing in windy conditions. It also overhangs next door's garden (Number 46 Woodsome Road)
Reduce the overhang of branches onto our property by 1.8 meters from the bay tree located next door at number 50 Woodsome Road. No significant reduction in height other than to finish aesthetically.
It is our intention to plant a mature Acer, Birch or similar to replace the conifer.
