T3: Prunus (9m): Re-Pollard to previous points removing 2m of re-growth and remove 1 stem over garden to keep tree at a size suitable for its location
T4: Ash (14m): Re-Pollard to previous points removing 2m of re-growth to keep tree at a size suitable for its location
T5: Sycamore (12m): Reduce height by 4m and shape to keep tree at a size suitable for its location
