e.g. Oak (T3) - fell because of excessive shading and low amenity value. Replant with one standard ash in same position.

Oak (T1) - Crown reduce to previous reduction points (1-2m) and lift crown by removal of secondary and tertiary branches to achieve a height of 5.5m above ground level. This work is regarded as cyclical maintenance for a tree in such an urban environment, using best arboricultural practice to ensure the health of this important amenity tree.
