Work required- Reduce and shape height by around 2m and spread by 1m.
Reason - As part of regular cyclical maintenance, to keep at a manageable size for the space

Tree number - S1
Tree type - Bay (Laurus nobilis)
Approx Height - 5m
Location - Rear garden, Right hand boundary
Service - Prune
Work required- Reduce by removing annual growth, pruning to best form (approx 1m from height and 0.3m from spread.
Reason - As part of regular cyclical maintenance

Tree number - T2
Tree type - Lilac (Syringae sp.)
Approx Height - 5m
Approx Crown Spread Diameter - 3m
Location - Rear garden, Left hand boundary
Service - Crown Reduction
Work required- Prune to best form by around 1m.
Reason - To rebalance crown and encourage best form
