T1. Mimosa tree fell and poison stump. This is at a grave angle and appears that some roots have started to lift. For safety reasons I believe this tree should be removed. Refer to photos.
T2. Mimosa tree overall crown reduction by approximately 1.5m. This tree was reduce like this before in passed. This would help with light for neighbour's and maintain sustainably for the tree.
T3. Eucalyptus tree fell and poison stump. Again a grave lean and roots are lifting.
T4/T5 Eucalyptus trees overall crown reduction by approximately 1.5m. Trees are touching nearby buildings in neighbours.
