Tree No. 1 Weeping Willow

Observations - Numerous cavities in lower main stem exposing established hollowing of main stem and lower branches. Recommendations - reduce tree to approximately five metres in height, back to original pruning/pollard points

Tree No. 2 Lime Observations - large regrowth above previous pollard points

Recommendations - reduce back to previous pollard points
