2 x Hornbeam at rear of property: reduce by up to 2 metres; all cuts to suitable growth points in line with BS3998. 2 x Birch trees on rear border: fell to ground level: these trees have been heavily reduced before and have bad form and significant decay in the upper crown. Both trees are of low amenity value and are surrounded by trees and shrubs so will not affect foliage cover.
