Magnolia Grandiflora: Approximately 8.00m. Reduce crown by approximately 1.00-1.50m. Raise crown over 5 Albert Terrace by approximately 1.00-1.50m. Thin crown density by 15-20%. Remove dead wood throughout. Ensure a 1.00-1.50m clearance of the building.

Reason: General maintenance to control encroachment.
