Horse Chestnut T1 (20M high, 1000mm dia.) - Reduce the crown of the tree, by up to 4 metres, back to most recent points of reduction. Thin crown throughout by up to 20% by removal of small branching only (maximum 75mm diameter).

Reason: Causing excessive shading to tennis courts and garden area

Located in front garden on LHS next to drive:

Lime T2 (16M high, 500mm dia.) - Reduce the crown of the tree, by up to 4 metres, back to most recent points of reduction.
