### **NO OBJECTION TO SECTION 211 NOTICE OF WORKS TO TREE/S IN A CONSERVATION AREA**

Proposed Work:

COURTYARD AREA: 1 x Apple Tree (Malus) (T1) - Remedial prune of broken branches back to suitable growth points. Reduce crown by approx. 30%.  
1 x Yew (T2) - Remove climbing plant. Reduce crown by 20% to tidy and balance shape.  
1 x Ginkgo (T3) - Remove all climbing plants from the tree.  
1 x Bay (T4) - Reduce crown height by approx. 30%. Reduce lateral and sub lateral crown spread by 30 - 40% in order to form a more compact crown structure.  
1 x Sycamore (T5) - Prune torn out stubs back to main stem.

The Council has considered your notification of intended works to trees dated 17 February 2021 and does not wish to object.

Informative(s):

- 1 This notice is valid for 2 years from the date of this letter or until the work is completed, whichever is the sooner.
- 2 You are advised that the appropriate standards for tree work are set out in BS 3998: 2010. Failure to ensure that the proposed works are carried out to these

standards may result in damage to the tree(s) and may result in legal action by the Council.

- 3 Please note that any approval given by the Council does not give an exemption from the requirements to comply with the Wildlife and Countryside Act 1981 (as amended), or any other Acts offering protection to wildlife. Of particular note is the protection offered to bats, birds and their nests from construction works.
